**OFFICIAL CONTEST RULES**

WBZO-FM, 94.3 The Shark – WWSK-FM, 104.7 WHLI-FM and 1100 WHLI-AM)  
hereinafter referred to as the “Stations”

No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.

**1. Promotion Dates**

*The Stations, all owned and/or operated by Connoisseur Media, LLC (CONNCOS) are running a multi-station or single station promotional contest (the “Contest”) from on or about March 4, 2024 at 12:00 am EDT which will end on or about April 19, 2024 at 11:59pm EDT (the “Promotion Dates”).
